  - 4. No student who is in receipt of any other scholarship or stipend including national loan scholarship from the State or the Central Govt. of the UGC shall be eligible for grant of Merit scholarship. However, students enjoying any such scholarship or stipend shall be required to surrender one of the two scholarships. Necessary undertaking shall be secured from the students to this effect before any part of the University scholarship is paid to him/her by the Head of the Department/Centre/ Institute.
