


**Minutes of Meeting**



### Minutes of meeting

A meeting of undergraduate board of studies (special) was held today on 02-11-2021 under the chairmanship of Dr Adil Gani, Coordinator, Department of Food Science and Technology, University of Kashmir, Srinagar in the conference room of the department. The meeting was convened to discuss the course structure and peruse the syllabus for Skill course in Food Technology for add-on and embedded components wherein the following points were discussed:

1. **Course structure details:** The draft syllabi provided by mentor institute was perused wherein members suggested several modifications which were made. The number of credits allocated to each semester is 04 which comprises of 2 credits theory and 02 credits practical. This equals to 12 credits for three semesters. In addition to it 18 credits were assigned to practical work/training.

2. **Course titles:** Following courses are to be adopted for each semester:

3. **Training component and Practical work:** The internship/training component consists of 18 credits of practical training. The training may be imparted by the Food industry/mentor institute/Hub College/affiliating university whichever is feasible on the basis of infrastructure required/nearness to the college where the skill courses are taught. The training must be given for a period of not less than 45 working days with at least 6 working hours for each day. The training may be imparted either in a single go or in splits of at least 15 days at a time preferably during vacations.

**4. Syllabi of each course:** Certain modifications were recommended by the members of the BOS in the proposed syllabi of the courses which were made. The modified syllabi has been drafted and it attached with the minutes




