Details of the Grievance: Furgan Ahmed submitted a grievance stating that although he was allotted a hostel room on time, he is requesting a transfer to another hostel on health grounds. He highlighted the specific health concerns that necessitated the move and requested the committee's assistance in facilitating the transfer.

Initial Review: The SGRC received the grievance on 6th Nov., 2023, and scheduled a meeting to address the issue on Nov 10th, 2023 with a follow up date: 16th Nov, 2023

Action Taken:

- Furgan Ahmed was informed and transferred to the new hostel on Nov. 20th, 2023.
